EU SME Centre renews the partnership agreement with the Estonia-Asia Trade Agency

On 17 June 2021, the representatives of the EU SME Centre (the Centre), Renzo Isler, and the Estonia-Asia Trade Agency (EAS), Eva-Kristina Ponomarjov, signed a new Memorandum of Understanding (MoU) to further strengthen the relations between China and Estonia.

EAS and the Centre signed the first cooperation agreement back in 2015 and, since then, both parties have actively worked on creating synergies and supporting Estonian SMEs develop their presence in China.
