Get Ready for China!

The EU SME Centre is an EU Commission funded project which helps EU SMEs prepare to do business in China by providing them with a range of information, advice, training and support services.

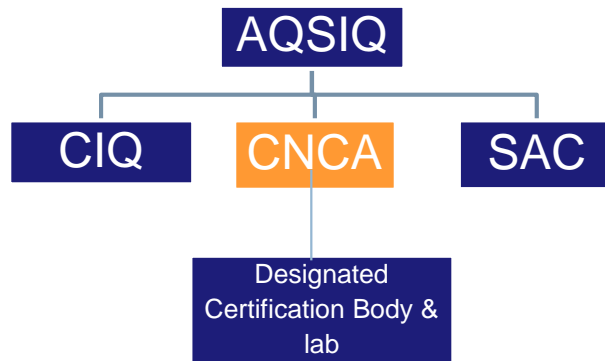

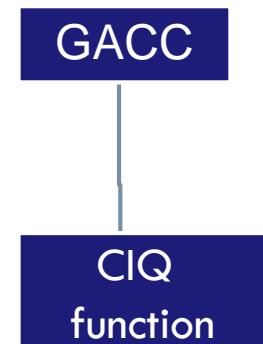
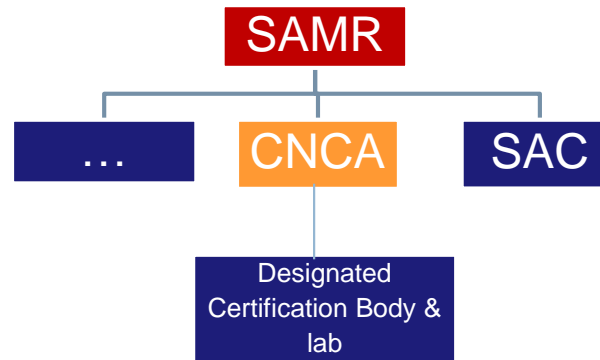
Brief Introduction of CCC

- A certification requirement for product quality standardization;
- Applies to both imported goods as well as to Chinese products;
- Proper use of CCC licenses and marks are required;
- Failure to meet the CCC requirements will lead to goods detained at the port or returned.

31 designated certification bodies (e.g. CQC-China Quality Certification Centre)

Scope of CCC

Certification Categories

- CNCA publish the Certification Catalogue*
- Products may be removed from/added to the Catalogue
- Currently 119 products in 21 categories,
- Of which 27 products apply self-declaration
- Incl. certain types of toys, cables, electric tools, medical devices, vehicles and accessories, etc.

Technical requirements for CCC

CNCA Implementation Rules

- CNCA responsible for the official Implementation Rules;
- 46 Implementation Rules are published *
(the latest updates in Sep.2018)
- Modified and updated un-regularly
- Chinese national compulsory standards (GB standards)

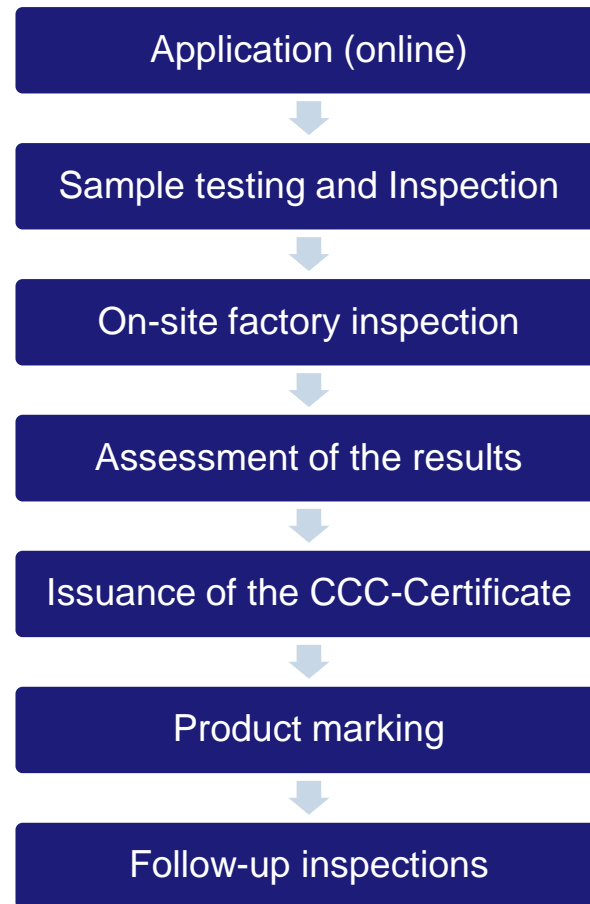


Application for CCC

Application Process for CCC

The approval process usually includes the following steps:

≥ 3 months





CCC exemption

6 scenarios that are applicable to CCC exemption

- 1) Products for R&D and testing purpose
- 2) Parts/products directly used for repair for end user
- 3) Equipment/parts needed for factory production line/complete production line (excluding office equipment/supplies)
- 4) Products for commercial exhibition purpose only, not for sale
- 5) Parts imported under General Trade used for manufacturing of machine for the purpose of exporting the whole equipment
- 6) Other special circumstances

Changes of CCC regulation in 2019

Products introduced into CCC Catalogue

SAMR Notice [2019] No.34*

- Products being introduced into CCC catalogue (e.g. household refrigerators with a calibration capacity of over 500L);
- New implementation rules for explosion protection products published;
- Mandatory from October 1, 2020.

Changes of CCC Catalogue and Management

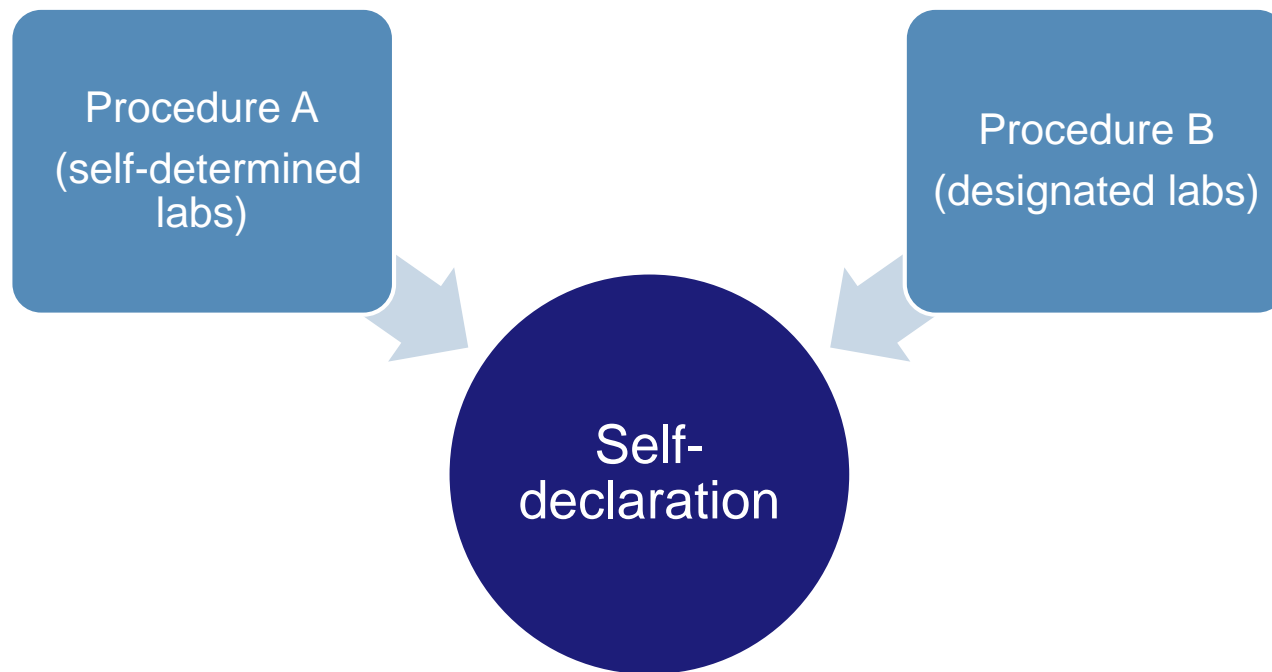
SAMR Notice [2019] No.44*

- Removes 18 products from the CCC Catalogue (e.g. Automotive components: interior trimming products; Door Locks and Door Retention Components);
- 27 products apply for self-declaration in total, of which 7 subject to **Procedure A** process, 20 subject to **Procedure B**. (e.g. automotive components: safety belt; safety glass);
- No CCC certificates for the products applying CCC self-declaration mode.
